#### Division: SSA

#### **Updates:**

#### New SSA hired and training:

Katelyn Middlesworth started December 9th and is currently in training. Katelyn has been an SSA before and is learning the job quickly. She is, however, new to completing the OISP due to her position in Montgomery County. While in Montgomery County, Katelyn primarily assisted with referral and linkage to community resources for individuals who were not on waivers. The SSA division is very glad to have her on our team.

SSA Service Highlight... this month's service highlight focuses on **Crisis Intervention**: On the Monday before Thanksgiving, the SSA Division received a call from a parent stating that they were no longer going to be able to keep their child in his 20's due to their behavior. There have been a lot of issues with this individual and the family and they were asking for immediate assistance. They reported they were packing them up as we spoke.

Due to the availability of the respite home, we were able to acquire staffing quickly and get the individual settled into the respite home that day. This individual ended up utilizing the respite home with staffing through the week (weekends are reserved for the scheduled weekend visits) and the individual stayed with another family member over the weekends.

This all happened while we had 2 SSAs on leave. The teamwork that the SSA division shows every day is astonishing, especially when there is a crisis. The SSAs are amazing and caring staff!

#### **Program Information:**

#### **HEALTH CARE ASSESSMENT:**

• SSAs received information and guidance on a new waiver service called healthcare assessment to begin January 1, 2025. This is a service that will be billed monthly to an

individual's budget; it allows them unlimited access to virtual and telehealth medical services with a physician, PA, or advanced nursing practitioner to help reduce ER visits for our individuals. This service helps individuals, and their caregivers understand health symptoms and identify next steps. Attachment with the highlights of this service is included with this report.

- Station MD was approved to become a provider at the end of the year and the SSAs are fast and furiously trying to get this new waiver service in the OISPs for those individuals in the pilot project.
- Currently the SSAs must get 46 plans updated to include this new service.
- This includes making the revision and getting all signatures from all team members and sending out the new plan
- SSA's will also be discussing this new service with individuals/families who have a need for virtual health care assessment.

**New "News":** Several caseload changes have been made for SSAs due to moving toward specialized caseload: Employment navigation and behavior management, along with nursing.

November and December saw an increase in preadmission screening requests for individuals with indications of DD to be admitted/remain in nursing facilities. There was also an increase in 811 Housing activity with a combination of processing individuals whose names came up on the list for housing opportunities and completing new referrals for individual to be added to the list.



#### **Updates:**

#### Voices of Greene County (VOGC):

- The Voices of Greene County continues to meet with Voices matter of Montgomery County.
- The Teams came up with the idea of doing a service projects for the Humane Society by making some dog and cat toys along with bringing in items the kennels needed at the November meeting.
- Andy H. VOGC member with his father gave a presentation on his recovery and Rehab from leg surgery and how appreciative he is for the support from other team members. Andy is making steady progress.
- The Teams planned and invited representatives from Ohio DDS Council to our next zoom meeting to present and talk about the annual survey they send out every year.
- The Teams planned the December Christmas party, and will also celebrate Chief Jeff Fiorita's retirement from Beavercreek Police Dept.
- Donna Foster and Latisha from Ohio DD council presented information and training to the group on the annual survey. As well as asking if any members were interested in becoming board members of Ohio DD Council.
- The Teams celebrated Chief Jeff Fiorita's retirement by giving him cards, telling him how much they appreciate all the support he's given to the Team.
- Chief Jeff commented on meeting Jenny and Andy when they gave a disability awareness presentation to the Beavercreek Police Dept. and how important he and the police dept. relationship has been with the Voices of Greene County. Jenny's mom, Patty also attended said how appreciative and thankful she was for having people like Chief Jeff in the community and connected to our team. As well as being proud of how far the Team has come.

- Team Discussed how they are putting self-advocacy into practice by speaking up in meetings, sharing ideas on what to do in meetings, connecting with their community, recruiting new members, sharing concerns they have, supporting each other during challenging times.
- Discussed with the Teams how the meetings were going they all indicated they were happy with the meetings and liked the location.
- Teams discussed doing a service project and or connecting with Stillwater Health Center. Voices of Greene County and Voices Matter both indicated they knew people who lived there who are medically fragile and somewhat isolated.

#### What is Staying the Same:

- "Non-Medical Transportation" still means transportation used by an individual to get to, from, between or among their place of employment, a location where adult day support, career planning, group employment support, individual employment support, or vocational habilitation is provided, volunteer activity, a postsecondary educational program, an internship or practicum and/or a drop-off or transfer location from which the individual is then transported to or from one of the places noted.
- DODD-certified NMT-Commercial Providers are still required to charge their published usual and customary fare.

- Rates for NMT Per Trip/Per Mile (other than the new special rate) are the same as currently listed in Appendix A of this rule. Nothing prohibits an NMT provider from billing the routine rate to take someone to community integrated employment.
- Budget Limitations have not changed.

The Healthy Relationship Team is working with Empowered to schedule a Provider Training and with a private provider alongside the individual they work with.



#### **Updates:**

**2024 Federal Quota Registration of Blind Students-** Each year, the Ohio Department of Education, Office of Exceptional Children, requests that all Ohio districts participate in the Federal Quota Registration of Blind Students. This registration provides an allotment of funds to purchase accessible educational materials, including text books and equipment, for any registered child/student. These materials are purchased through the American Printing House for the Blind, Inc. (APH) and the registration process is conducted on behalf of the Department by the Assistive Technology and Accessible Educational Materials (AT&AEM) Center at OCALI. Our program makes sure to register every child who meets the eligibility requirements and whose parents/caregivers give permission. I will have them submitted next month per the deadline.

# From the Department of Children and Youth, the resource below was shared. It is a great testament to the services Early Intervention provides and the importance of acting early. Stepping Stones Video Series Announcement

In this seven-part video series, families of children with disabilities share their experiences of being involved in Ohio Early Intervention. #### Noteworthy Monthly Data/Numbers:

Our Active IFSP number for November 2024 was 239, and our teams completed 24 evaluations. Our Active IFSP number for December 2024 was 237, and our teams completed 20 evaluations.

**Greene County EI received 31 new referrals in November and 44 new referrals in December (32 in October and 35 for each of the 3 months prior).** Referrals have remained elevated the past several months. The highest referral sources were parents, then physicians, followed by other various sources such as hospital child find specialists, Children Services, etc.

#### 2024 Totals:

We received a total of 406 Referrals in 2024.

**Our Early Intervention teams served a total of** <u>490</u> **infants and toddlers in 2024**. In 2023, we served 530. In 2022, we served 489.

**Our Teams completed 286 evaluations and assessments in 2024.** In 2023 we completed 334. In 2022 we completed 298.

#### **Program Information:**

We have scheduled additional Mental Health trainings in 2025. Additional details will be shared in future Board Reports

Our Autism Diagnostic Education Program (ADEP) Team has an evaluation scheduled in January. Our ADEP Team includes Raleita Furlow, MSEd (DS and ADEP Coordinator), Gina Tulamarie, MA, CCC/SLP, Anne Marie Cardilino, MS, CCC/SLP, Jennifer Montague, MS (DS and PLAY Consultant), and Robin Stewart (DS and PLAY Consultant). Our medical partner is Dr. Boreman, MD, FAAP, Medical Director of the Autism Center and Developmental-Behavioral Pediatrician at Dayton Children's Hospital.

**P.L.A.Y. Project (Play and Language for Autistic Youngsters Project)** – parent implemented, intensive early intervention program for young children with autism that is evidence-based. Our P.L.A.Y. Team includes Jennifer Montague (PLAY Coordinator, DS, and PLAY Consultant), Beth Brennaman (DS and PLAY Consultant), and Tina Snyder (OT and PLAY Consultant). \*\*\*The team is continuing to serve 9 families whose children in the program are all between the ages of 3 – 5.

#### Special Events/Activities:

**Greene County Board of Developmental Disabilities are continuing to partner with Greene County Parks & Trails for monthly events in 2025.** Early Intervention's events called "Toad-ally Together" are scheduled for June and August this year. These events are meant to bring kids and families of all abilities <u>together</u>. We are already looking forward to another year of partnering with GCPT and providing these fun and inclusive activities.

I am happy to share that the Toad-ally Together program won 2<sup>nd</sup> place in the adaptive category at the Ohio Parks and Recreation Association! Thank you to GCPT and to all the staff who worked so hard planning and helping to make these events a success!

#### November:

**Dungeons and Dragons 11/6 and 11/27:** The D&D group continues to evolve and become more self-sufficient. This month there was a scheduling conflict and the group changed the

date of their meeting by using the text message group we created. It is very encouraging to see them taking the initiative for planning their own events. This is the model for what we want moving forward.

**Coffee Talk 11/7:** Coffee talk was attended by approximately 30 individuals from a few day programs. Towards Independence (since it is in their lobby), Empowered, and Residential Home Association usually attend.

**Speed Friending 11/13:** The speed friending event was a huge success. This event was a capstone to a 6-week Healthy Relationship series that was hosted by the GCBDD Healthy Relationship Team. Many new relationships were formed and it was evident that new skills and confidence had been gained by the participants. The GCBDD Healthy Relationship classes are a major game changer and we will hopefully do this again.

**Diner's Club 11/18:** Diner's Club took place at Golden Corral in Beavercreek and had uncharacteristically low attendance (around 40). Despite the low attendance, everyone had a good time.

#### 2025 and Beyond!!

There are a few changes and improvements on the horizon for All Hands In for 2025.

- 1. Josh and Megan and going to be implementing a new RSVP system. Currently people RSVP for all of the events to Josh's email, text, and voicemail and as well as Megan's email, text, and voicemail. This is becoming very difficult to manage across all of the events. Sometime in 2025 a new RSVP system or software will be implemented. We aren't sure what it will be yet. We are shopping around for the most streamlined and affordable option.
- 2. FAST meetings begin in January. FAST stands for Families Achieving Success Together. These meetings will be parent lead with topics that address issues related to young families with disabilities. FAST will be like the SALT meetings but for younger families. This will be a good way for GCBDD to offer some extra value to the younger families we serve. Meetings will take place quarterly and will happen in the GCBDD conference room as well as a virtual option. Please see the attached flyer for more information.
- 3. There are many new All Hands In events on the horizon, but these will be different. Due to the success of Dungeons and Dragons, we are going to be angling in that

direction. In January we are starting a new group called "Nerd Nation". This will be hosted by one of the folks we serve, Janel Hartman. The focus of this group will be for folks to get together and talk about things that are of common interest. Things like Anime, Comic Books, D&D, Cosplay, Star Wars, etc. This is just one of many new groups though. We also have another group firing up around YouTube, social media, etc. as well an art focused group called "The Artist's Collective". The goal with these groups though is for them to be participant led. We are finding that this is best way for our folks to develop genuine friendships.

4. Beginning in 2025, All Hands In is hoping to dip their toes in the employment game (at least a little bit). Josh is currently working with Towards Independence to help them explore their options for providing employment services. In addition to this, All Hands In is planning to coordinate monthly Career Exploration field trips for Day Programs. Why you might ask? It's simple. A bunch of the folks that attend All Hands In events are capable of working in the community. Many (actually most) of our events take place in the community and require participants to spend their own money. It just makes sense to encourage more of our folks to be working in the community. And isn't engaging with the community what All Hands In is all about?

#### **Program Information:**

*Effective January 1, 2025, following CMS approval, a new DODD waiver service has been added and updates made to a few others.* 

#### New Service: Health Care Assessment

This is a monthly subscription service available in all three of the DODD Waivers – Individual Options (IO), Level 1, and Self Empowered Life Funding (SELF).

Health Care Assessment service provides a real-time virtual health assessment to determine the best clinical course of action and to help avoid unnecessary emergency room visits.

The service will assist an individual and/or the individual's caregivers to understand the individual'spresenting health symptoms and identify appropriate next steps.

#### Updated Service: Non-Medical Transportation

Commercial Transportation definition updated to an entity that transports passengers inaccordance with a published usual and customary fare schedule and is either a bus or rail system or an on-demand taxicab\*.

Special rate for taking a person to Competitive Integrated Employment\*. The Non-Medical Transportation to Competitive Employment rates are per trip-based on three mileage bands and if the person requires modified or non-modified vehicle.\* A provider must transport only one individual at a time to bill this rate.
